

**LAARS HEATING SYSTEMS COMPANY**  
**BREAK THE BANK PROMOTION TERMS AND CONDITIONS**

**Applicability.** The Break the Bank Promotion (“Promotion”) is offered by Laars Heating Systems Company (“Sponsor”) to reward eligible contractors (each a “Participant”) purchasing Qualifying products with a VISA Gift Card. This Promotion applies to Qualifying Purchases (as defined below) made between September 9, 2024, and November 1, 2024, inclusive (the “Promotion Period”). By participating, you agree that you have read and agree to these terms and conditions.

**Eligibility.** This Promotion is open to entities organized under the laws of the United States, any state thereof, or the District of Columbia and/or legal residents of the United States who are 18+ years or older at the time of purchase. Employees, officers, and directors of Sponsor, its affiliates, subsidiaries, advertising and promotional agencies, and their immediate family members (spouse, parent, child, sibling, and their respective spouses) and those living in the same household of each are not eligible to participate.

The VISA Gift Card is subject to VISA’s terms and conditions. Complete the redemption form (P.O. Boxes are NOT accepted) and enclose it with the proof of purchase showing your Qualifying Purchase(s) made during the Promotion Period. Incomplete forms will be ineligible and will be denied. The VISA Gift Card will be mailed to the address provided within 4-6 weeks of processing of the redemption form.

**General Conditions.** Sponsor reserves the right to verify the eligibility of all Participants. In the event of fraud, abuse, or any form of misconduct, Sponsor reserves the right to void the reward and disqualify the Participant. Sponsor reserves the right to cancel, suspend, or modify the Promotion if any fraud, technical failures, or any other factor beyond Sponsor’s reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole

discretion. Sponsor’s decisions are final and binding in all matters relating to the Promotion.

**Governing Law.** All matters arising out of or relating to this Agreement are governed by and construed in accordance with the internal laws of the State of Michigan without giving effect to any choice or conflict of law provision or rule (whether of the State of Michigan or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than those of the State of Michigan.

**Submission to Jurisdiction.** Any legal suit, action, or proceeding arising out of or relating to this Agreement shall be instituted in the federal courts of the United States of America or the courts of the State of Michigan in each case located in the County of Kent, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action, or proceeding.
